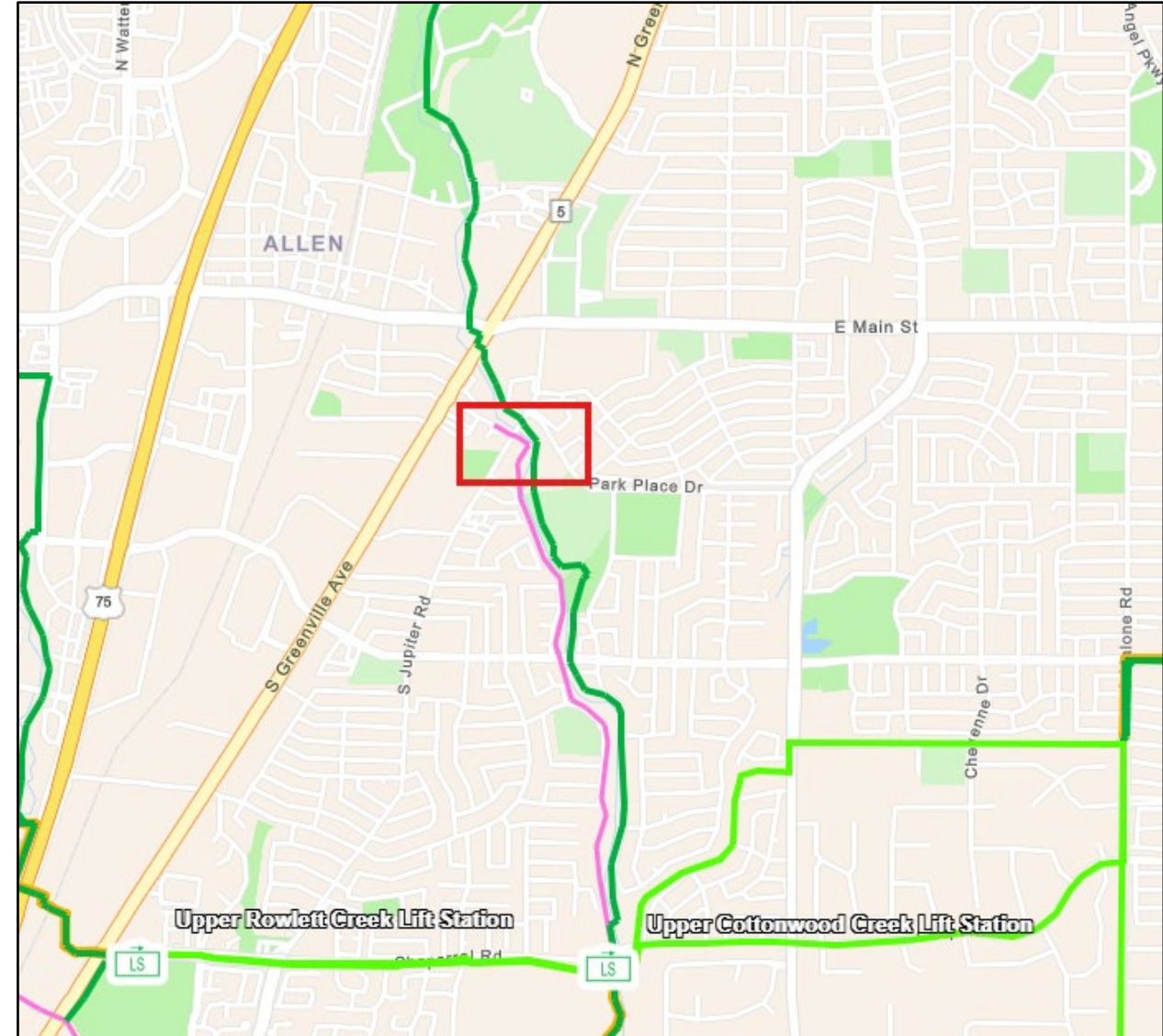

Cottonwood Creek Bank Stabilization

- February 2024, the City of Allen notified NTMWD of stream bank erosion in the vicinity of the Cottonwood Creek Trunk Sewer Pipeline
- The erosion compromised the City's concrete trail that runs parallel to Cottonwood Creek prompting them to close the trail
- Exposure of the NTMWD Cottonwood Creek Trunk Sewer pipeline
- Field investigations identified the need for immediate temporary measures to protect the District's pipeline infrastructure





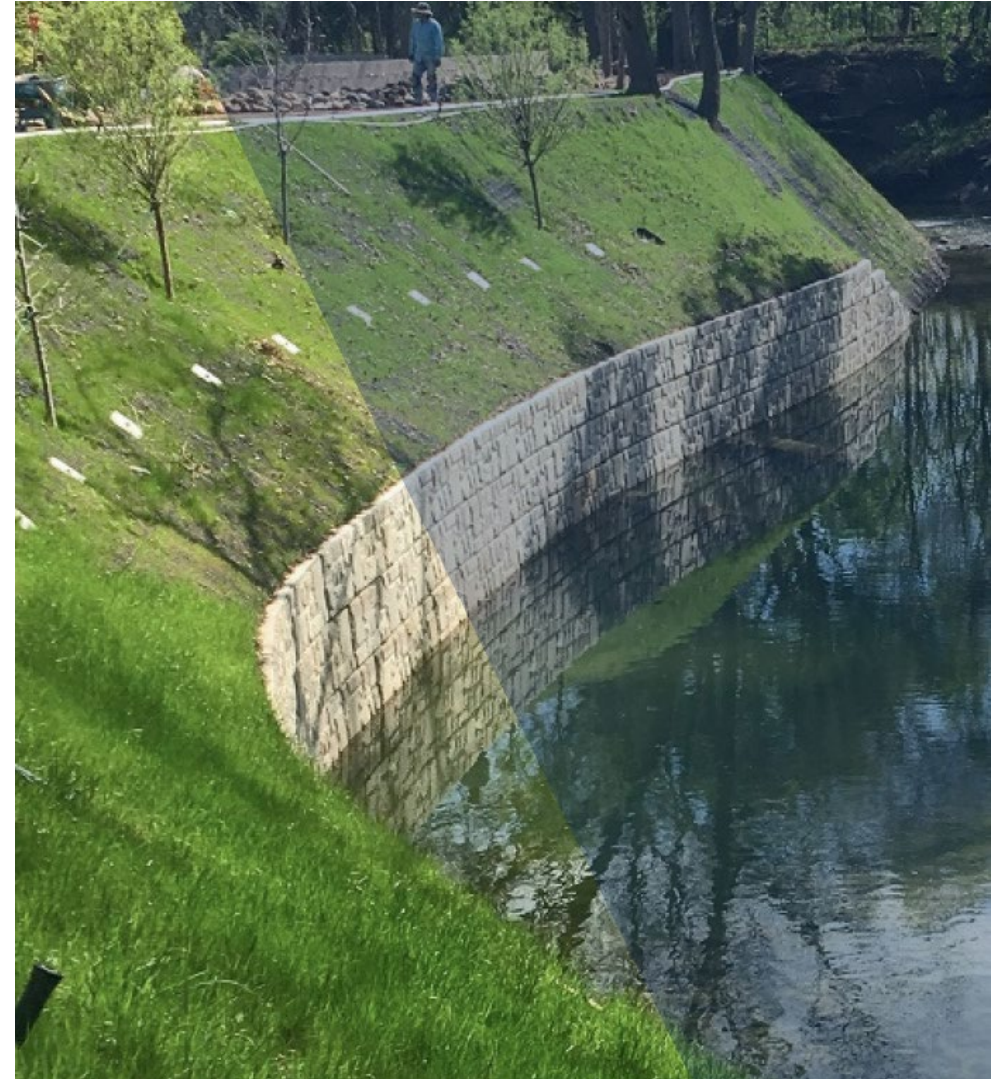
Cottonwood Creek Bank Stabilization

- NTMWD took action to install temporary stabilization measures to protect integrity of the pipeline



Cottonwood Creek Bank Stabilization

- NTMWD and the City of Allen have been collaborating on a more permanent solution
- Progress to date
 - City has solicited proposals from contractors
 - City and NTMWD have reviewed proposals and conducted interviews
 - Current proposal - Concrete Block Wall with Turf Reinforcement





Cottonwood Creek Bank Stabilization

- Interlocal Cooperation Agreement highlights:
 - NTMWD will participate in selection of the contractor and review of the design
 - City will manage the design and construction of the project
 - Total Project Cost of \$645,457
 - NTMWD's one-time contribution is \$387,275
 - All other costs will be paid by the City of Allen
- Next Steps
 - NTMWD Board approve Interlocal Cooperation Agreement (February 27th)
 - City approve Interlocal Cooperation Agreement (March 11th)
 - City award construction contract (March 11th)

Lower Rowlett Creek Lift Station Structural Repairs

Project Purpose

- Restore and enhance the structural integrity of the east and west lift station wetwells to ensure reliable transfer of flows to Wilson Creek RWWTP

Project Components

- Concrete repair on exposed reinforcement within both east and west wetwells
- Application of protective coating to reduce corrosion impact on concrete walls

Rowlett Creek RWWTP Construction Management

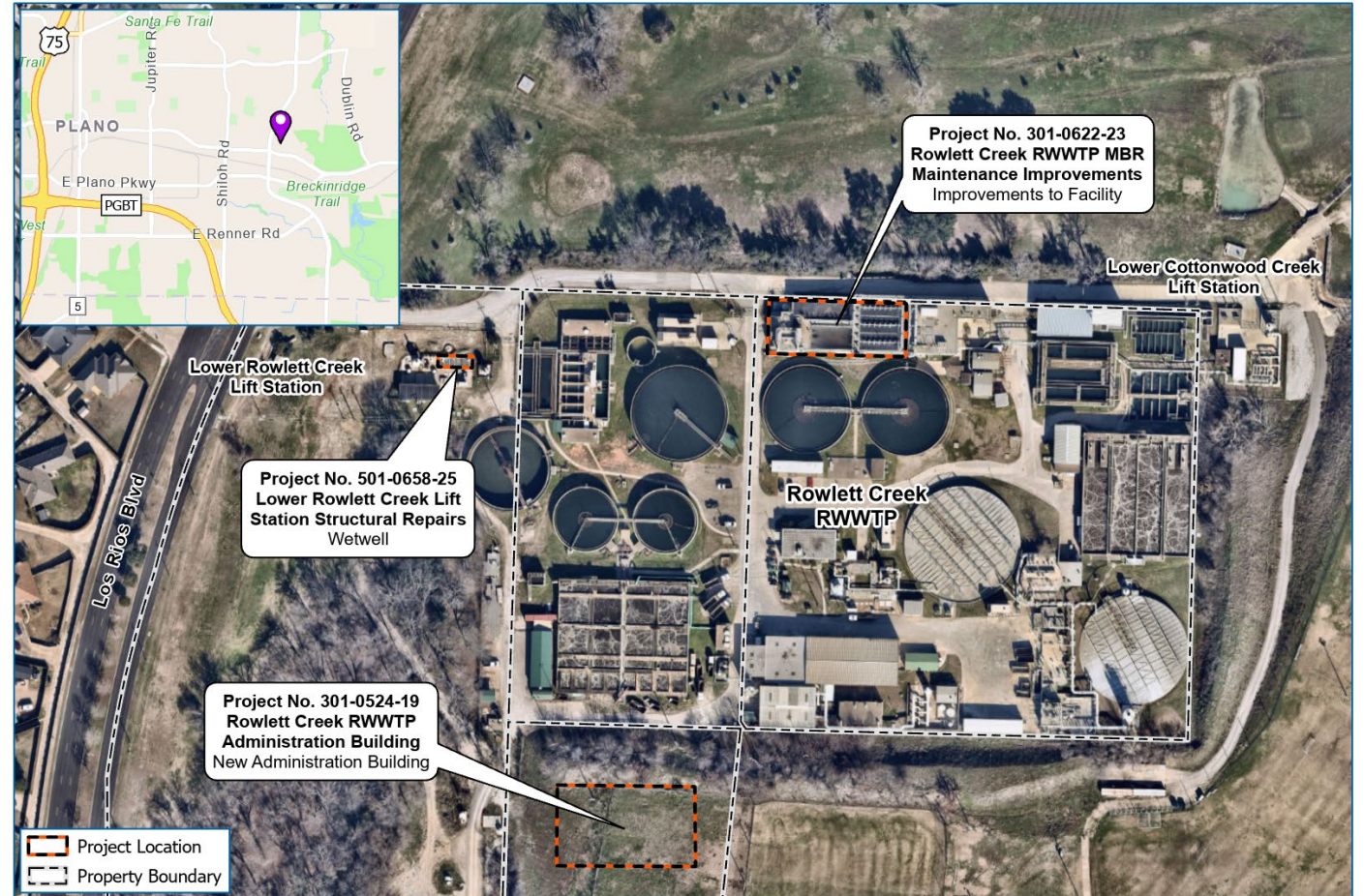
Background & Project Purpose

- Multiple construction contracts are planned to be awarded at the Rowlett Creek Regional Wastewater Treatment Plant (RWWTP) over the next few years
- A Construction Manager is needed to administer and oversee all the planned construction activities
 - Lower Rowlett Creek Lift Station Structural Repairs
 - Rowlett Creek RWWTP Administration Building
 - Rowlett Creek RWWTP MBR Maintenance Improvements
 - Rowlett Creek RWWTP Peak Flow Management Improvements, Phase II (future request)

Rowlett Creek RWWTP Construction Management

CM Services Scope

- Initial 12 months requested

Upper White Rock Lift Station – Pump 1 and 2 Replacement

Background & Project Purpose

- Upper White Rock Lift Station was constructed in 1995 and upgraded in 2016
- Receives flow from northwestern Plano and pumps to Preston Road Lift Station
- The 2023 lift station condition assessment report recommends improvements at the lift station to replace badly deteriorated components and repair moderate leakage in the dry well of the lift station to ensure reliability of the facility
- Planning Level Estimated Construction Cost is \$6,638,000



Upper White Rock Lift Station – Pump 1 and 2 Replacement

Project Components

- Replace:
 - Pumps 1 and 2
 - Associated piping and valves
 - Concrete lift out panel
 - Electrical equipment
- Repair concrete leak and crack in dry well
- Evaluate additional supervisory control and data acquisition (SCADA) system alarms, pump 3 piping and valves, and permanent bypass connection





Upper White Rock Lift Station – Pump 1 and 2 Replacement

Preliminary and Final Engineering

- Basic Services - \$771,137
 - Project management, data collection, and coordination

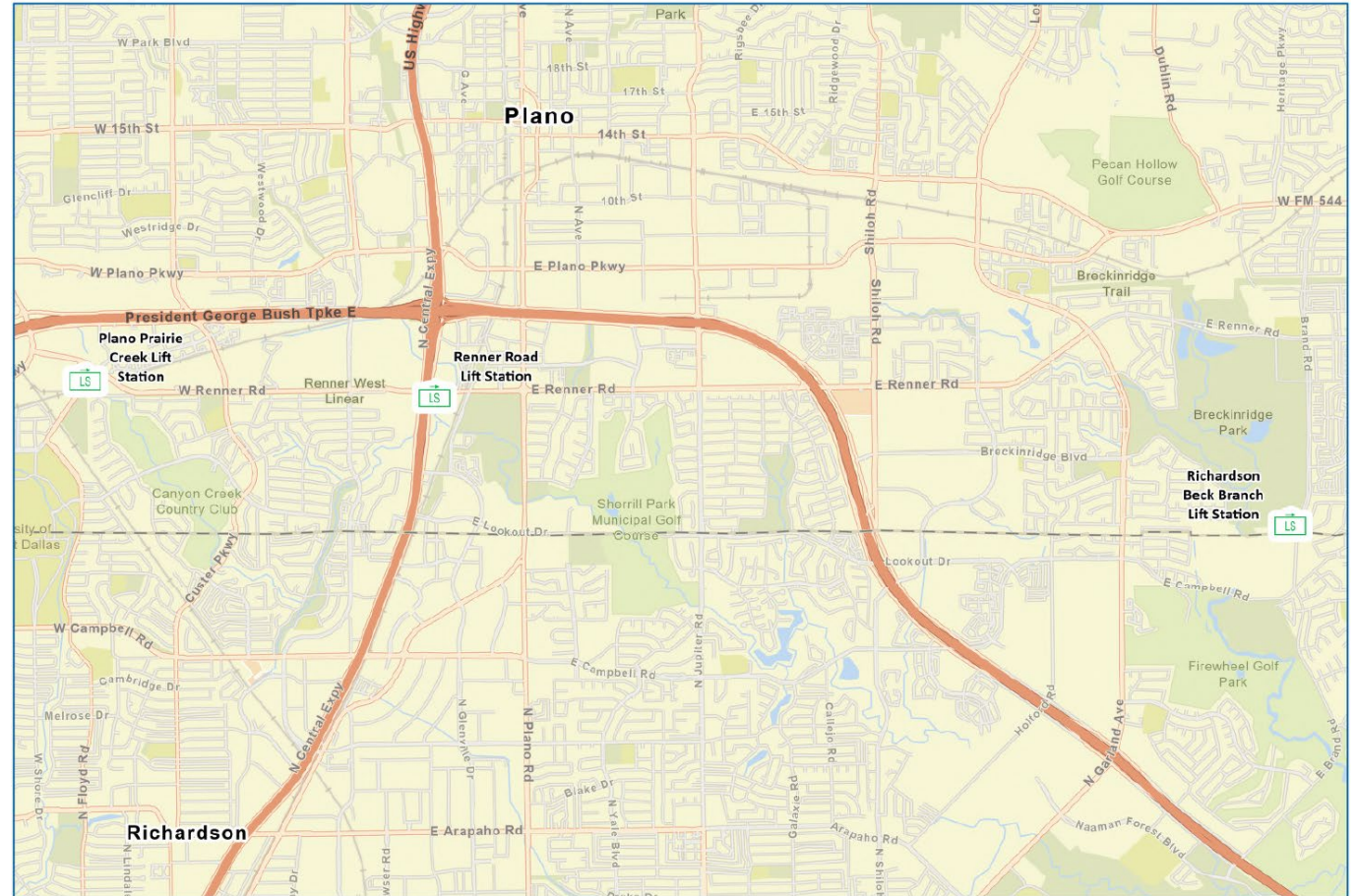
Beck Branch, Prairie Creek and Renner Road Lift Stations Improvements

Project Purpose

- Replace and rehabilitate aging and/or deteriorated equipment at the existing lift stations to improve reliability and ease of maintenance

Project Components

- Replace two pumps, valves, and piping at Beck Branch
- Permanent bypass connections at Beck Branch and Renner Road
- Odor control improvements at Prairie Creek
- Replace and upsize existing generator tank at Renner Road
- HVAC/Electrical improvements, and replacement of flow metering devices at all three lift stations

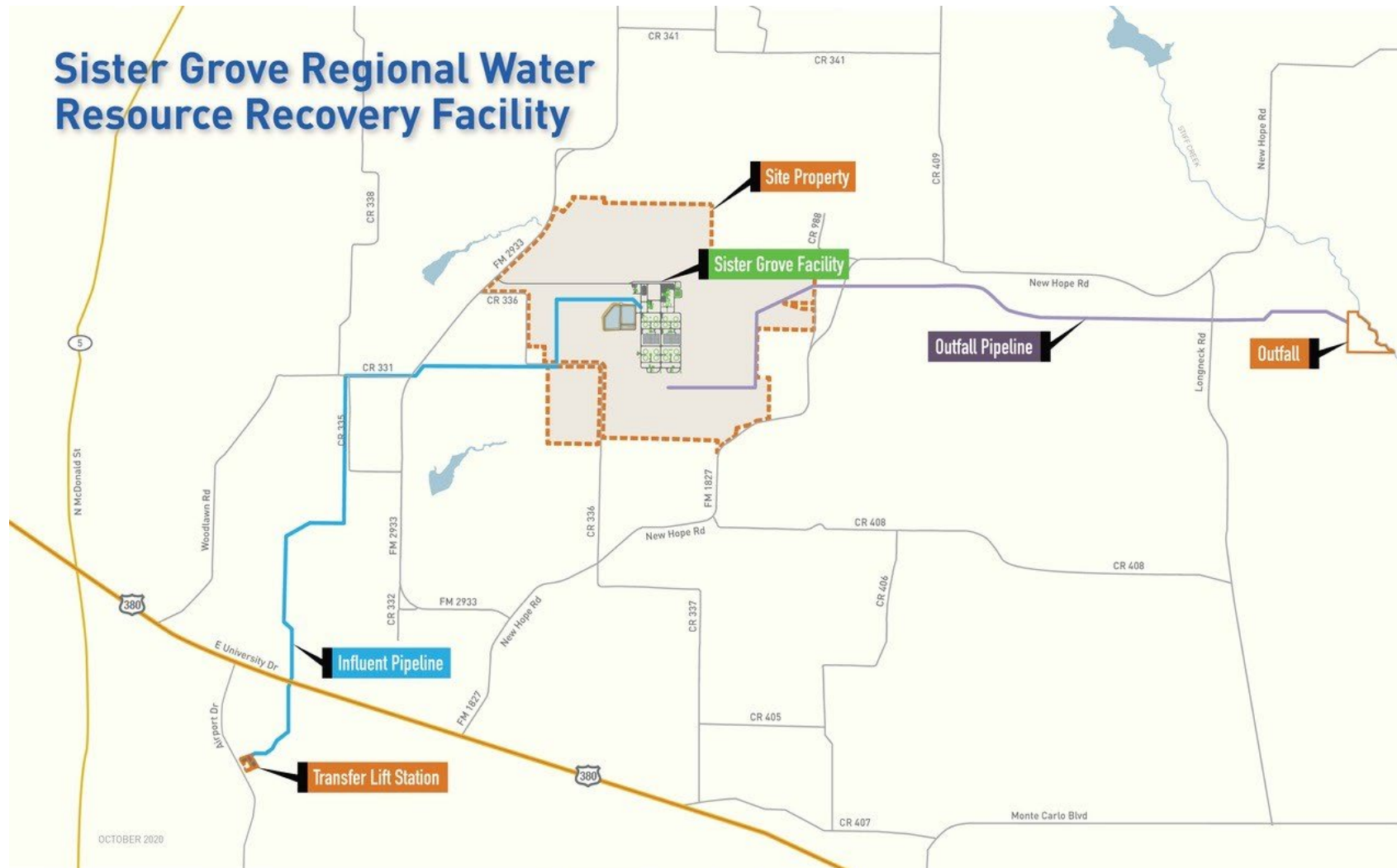

Progress Updates:

- Permanent Power was available at the site in October 2024
- The plant was energized on January 28, 2025
- Current projected date for Process Startup is August 2025

Separated Work Packages from CMAR's Scope:

- Construction of Main Electrical Yard - complete
- Plant Fiber Optic Installation – complete
- FM 2933 Improvements at Plant Entrance – advertise February 2025

Risk Management:

- Holding monthly Risk Register Update Meetings
- Identified approximately 48 risks and resolved or mitigated 35 items to date
- Focusing on potential startup risks

Sister Grove RWRRF Program Update

Expediting Construction Activities:

- Identified critical elements of subcontractor work and **moved to CMAR self-perform.**
 - Earthwork, structural slabs, masonry, fiberglass duct, insulation
- Analyzed electrical activities and optimized sequence to shorten durations and accelerate associated work.
 - Reduced the overall schedule duration by 54 days
- Extended work hours and additional weekend work activities.
 - Saturdays/Sundays worked in 2023: 42
 - Saturdays/Sundays worked in 2024: 45
- CMAR assigned interim milestones to subcontractors and is **supplementing subcontractor workforces as needed**

Sister Grove RWRRF Program Update

Startup and Contingency Activities:

- Identified initial Startup and Testing activities that can occur concurrently and independently to compress schedule.
 - Reduced the overall startup schedule by approximately 30 days
- Analyzed “Acceptance Testing” requirements and suggested revisions
 - 20 to 25 testing activities were identified and re-sequenced in coordination with project stakeholders to improve schedule
- **Analyzing options for plant startup without the use of Peak Flow Basins**
- Analyzing options to startup specific areas of the plant in Manual Mode as a contingency plan
- Analyzing options to startup and temporarily operate only half of the plant (single train) as a **contingency plan (treating 6-8 MGD) - Reduce startup time**

Program Financials:

- Professional services during construction will need to continue through project completion, therefore increases in the following were recently approved:
 - Program Management
 - Inspection (internal and external)
 - Engineering services during construction
- Current GMP for the project is \$474,732,865
- Our current expenditure through December 2024 is \$388,395,935
- Retainage is \$15.5M
- Remaining CMAR Contingency is \$1.8M
- Allowance in GMP not expected to be utilized is \$500K
