# Strategic Initiative Highlight

This month we would like to highlight a project that supports the efforts of multiple objectives and initiatives across the plan. Our Wastewater and Human Resources teams have been working with the Water Environment Association of Texas (WEAT) on joining the Texas Workforce Commission's (TWC) Apprenticeship Training Program. WEAT has worked with TWC to develop and offer a program for Water and Wastewater employees within the following trade groups: Operators, Electronics Technicians and Mechanics. Through this program TWC will provide 80 percent reimbursement of base salary for the first six months of employment for newly hired personnel that are enrolled in a developmental training program. WEAT acts as the intermediary for the program and manages all state required reporting requirements for the employer.

The NTMWD Wastewater Team worked diligently over the past three years to implement a training and competency development program (for Wastewater Operators, Conveyance

Operators, Odor Control Operators, and Maintenance Technicians) that is designed to establish minimum training standards for the Wastewater Department. They have also worked to ensure employees have a clearly defined path of progression with the Knowledge, Skills, and Abilities to compete for future promotions. It was the foresight and development of this program within the Wastewater Department that allows our newly hired Wastewater Operators to participate in the TWC Apprenticeship Training Program. Our teams in Wastewater and Finance are also working through how the reimbursed funds can be applied to the benefit of employees, other projects or goals, and the District in general.

We are appreciative of our partners at the WEAT for their coordination with TWC and willingness to partner with NTMWD to provide administrative reporting requirements for the program. Also, we appreciate the diligent work of our staff in the Regional Wastewater System, Sewer System and Human Resources who have worked together in bringing this program forward for implementation. Through these partnerships, this program is supporting the goals and activities of Objective 2.1 – Efficient Business Practices, Objective 3.3 – Durable Strategic Partnerships, Initiative 4.1.1 – Establish a Comprehensive Employee Training and Development Program and Initiative 4.3.1 – Establish Performance Goals, Track and Communicate Progress.

#### VI. OPENING REMARKS

A. <u>President's Remarks</u> concerning current events, conduct of meeting, posted agenda items, committee assignments, and related matters

President May advised that the District was saddened to learn that former Director, John Murphy, passed away earlier this month. Director Murphy retired from the Board of Directors in June of this year after being appointed by the City of Richardson in 2013.

President May thanked everyone who was able to attend the Bois d'Arc Lake Dedication, adding that Staff did a great job on the event.

President May noted that with the holidays approaching, the November and December Board meetings will be held on the third Thursday of each of these months.

President May reviewed the tentative list of meetings for November is as follows:

o Wednesday, November 2<sup>nd</sup> - Executive and Finance Committees

- Thursday, November 10<sup>th</sup>- Long Range Water Supply Work Session
- Wednesday, November 16<sup>th</sup>- Solid Waste, Real Estate, and Water Committees
- Thursday, November 17<sup>th</sup>- Board meeting

Staff is currently looking at an alternate date for the Long Range Water Supply Work Session. Director Murphy's funeral services are being held the same day.

B. <u>Executive Director's Status Report</u> concerning legislation and regulatory matters, budgets, current projects and ongoing programs of the District including the Regional Water System, Regional Wastewater System, Regional Solid Waste System, Watershed Protection, and Water Conservation

Executive Director Covington spoke of the Bois d'Arc Lake Dedication event held on October 14, 2022. She noted this is the first reservoir built in Texas in over 30 years. She reviewed the staff and organizations that were instrumental in planning a successful event, noting that 300 guests attended. A video of the ceremony and groundbreaking was presented.

Executive Director Covington announced that the City of Frisco selected Director Richard Peasley to receive its distinguished Veteran of the Year recognition. He will receive the award at Frisco's November 1<sup>st</sup> City Council meeting and will participate in the Veteran's Day parade on November 12<sup>th</sup>.

Executive Director Covington advised that the Budget in Brief for the next fiscal year has been provided to each Director, and the full budget is available to the Directors if they would like a copy and it is also posted on the District's website.

Executive Director Covington reviewed the recently completed Wilson Creek Wastewater Treatment Plant electrical improvements. She noted that the District's Engineering Department has received awards for this project.

The Board may not discuss these items but may respond with factual or policy information.

Brian Galuardi representing the City of Rowlett addressed the Board regarding Rowlett's interest in becoming a Member of the District. He advised that Rowlett has been a Customer for many years and advised that they hope to submit a petition to become a Member according to the District's Enabling Legislation. He also congratulated the District on the Bois d'Arc Lake project.

#### VIII. DISCUSSION ITEMS

A. Update on Sister Grove Regional Water Resource Recovery Facility

Deputy Director Cesar Baptista provided an update on the status of the Sister Grove Regional Water Resource Recovery Facility and the North McKinney Force Main and Lift Station. Location and site maps were reviewed as well as site photos. Mr. Baptista reviewed the financial status of the project, noting that approximately \$450 million has been authorized by the Board of Directors. The project schedule was provided.

B. Review of the fiscal year 2022 Regional Water System Variable Costs

Deputy Director Jeanne Chipperfield provided a review as follows of the <u>Administration & Finance Policy</u>, Section IV. Water Variable Cost Rebate as it was updated in August 2022:

- Board may consider a rebate of variable costs to Members and Customers who do not exceed their annual minimum for the Water Year.
- Rebate information to be reviewed at October Board Meeting and, if applicable, rebate payments placed on November Board meeting agenda.
- Total funds to be rebated calculated as the difference between the budgeted variable costs and the actual variable cost for the fiscal year. Should the variable cost budget be exceeded, then no rebate will be administered.
- Rebate funds are allocated to eligible Members and Customers based on the proportionate share of the underage on water minimums.

Ms. Chipperfield explained that the variable cost budget includes chemicals, power and certain water purchases. Two factors affected the variable costs in FY22:

- Extreme volatility in the chemical market required contract rebids; new contract price increases went into effect in June for several high usage chemicals.
- Extreme hot, dry early summer weather with unrestricted demands plus recent significant population growth significantly increased consumption in June and July.

Ms. Chipperfield advised that based on these factors, the FY22 amended budget for chemical expense was increased in July and August. At that time, it was communicated that a variable cost rebate would be unlikely due to the chemical cost increase. After that time there was a significant drop in demand following a call for conservation and rain, combined with additional chemical optimization efforts reducing actual chemical expense below levels previously anticipated. The total variable costs ended up slightly underbudget resulting in funds to be considered for rebate. Ms. Chipperfield provided a breakdown of budget and actual expense which reflects a preliminary rebate amount of approximately \$3 million, as well as an overview of consumption which dropped in the final three (3) months of the fiscal year. The list of Member Cities eligible for a variable cost rebate was reviewed.

Ms. Chipperfield advised that payment of the rebate does not negatively impact the District's fund balance. Operating and Contingency funds estimated balances were provided. If directed by the Board the rebates will be included on the Board's November agenda. President May directed her to proceed.

#### C. Review current fiscal year Capital projects

Deputy Director R.J. Muraski provided a comparison of the District's capital projects budget from previous years and the next six years, which is estimated at approximately \$6 billion. He advised this information is included in the District's Strategic Plan and has been provided to the cities.

Mr. Muraski provided a review of capital projects budgeted for FY22 for the Regional Water System, the Regional Wastewater System, the Upper East Fork Interceptor System and the Sewer System. Completed capital projects for FY22 were provided.

Mr. Muraski advised that for FY23 there are 24 design projects and 38 construction projects proposed. Those were reviewed. He noted that each of them must come before the Board for approval.

Discussion followed regarding the possible reimbursement of some relocation projects done at the request of TxDOT. Mr. Muraski noted that some of the smaller cities' pay for their own wastewater projects.

Location maps and project descriptions for FY23 were provided to the Directors.

A five-minute recess was taken at this time.

#### IX. EXECUTIVE SESSION

At 3:56 p.m. President May announced the need for an Executive Session of the Board of Directors to discuss items IX. A. on the agenda pursuant to the Texas Government Code, Section 551.071, Consultation With Attorney.



- 3. The Executive Director is authorized to employ surveyors to assist in the acquisition process, as required.
- 4. The power to initiate eminent domain proceedings is hereby delegated to the Executive Director and she is hereby authorized to take all steps necessary to acquire the easements for the Project; including the hiring of negotiators, appraisers, Title Company, and attorneys.
- 5. The Executive Director is authorized to employ the firm of Saunders, Walsh & Beard, Attorneys and Counselors, to represent the NTMWD in these land transactions; including filing of Petitions for Condemnation on properties when the Executive Director determines the property cannot be secured through negotiations and after issuance of a final offer letter in accordance therewith.



#### BACKGROUND

 Section 4 of the Administration and Finance Policy Manual, Water Variable Cost Rebate Policy, requires the NTMWD staff to provide the Board of Directors a schedule of Water System Variable Costs Rebates on an annual basis as a discussion item in October of each year and that after considering the financial condition of the NTMWD, the Board of Directors

shall either instruct the Executive Director to place the rebates on the November agenda for consideration, or accept the report as information only.

- The policy regarding Water System rebates was adopted in 1993. The policy was updated in August 2022 stating that the funds to be considered for rebate shall be calculated as the difference between the budgeted fiscal year variable costs and the corresponding fiscal year unaudited variable expenses in the Regional Water System.
- Rebates have been authorized each year except in 1996 and 1998.
- The total rebate amount for FY 2021-22 has been calculated to be \$2,793,511.32, and the NTMWD is in a financial position to fund the rebates.
- A copy of the 2021-22 Water Variable Cost Rebate Schedule is attached.
- The Water Variable Cost Rebate Policy specifically states that Member Cities/customers are not eligible for a rebate if they are establishing annual requirements by contract negotiations.

#### ACTION (What)

Authorize a termination agreement for two projects undertaken by Rayburn Country Electric Cooperative, Inc. (RCEC) to supply electric transmission service to the Bois d'Arc Lake (BDL) Raw Water Pump Station (RWPS) and the Leonard Water Treatment Plant (WTP).

#### PURPOSE (Why)

This action acknowledges RCEC is complete with both electric transmission projects, and the costs for those projects have been approved by the Public Utility Commission of Texas (PUC) for recovery under the Transmission Cost of Service (TCOS) program.

#### RECOMMENDATION

The Executive Director, NTMWD staff and Lloyd Gosselink Rochelle & Townsend, P.C., recommend the Board of Directors authorize the Executive Director to execute the "Termination Agreement" with Rayburn Country Electric Cooperative, Inc. as follows:

#### BACKGROUND

#### PROJECT PURPOSE

- Provide high voltage electric transmission service with its associated infrastructure to the BDL dam and RWPS.
- Provide high voltage electric transmission service with its associated infrastructure to the Leonard WTP and Leonard WTP High Service Pump Station (HSPS).
- Construct a portion of two electric power substations at the facilities listed above.

#### PREVIOUS AGREEMENTS WITH RCEC

- NTMWD agreed to reimburse RCEC for its costs to perform the engineering, environmental and legal work needed to submit a request for Certificates of Convenience and Necessity (CCN) from the Public Utility Commission of Texas (PUC) for the high voltage electric transmission lines, as well as the design for two electric substations, if RCEC's costs were not recoverable from the TCOS program. The CCN essentially gives RCEC the authority to construct the lines as well as the right of eminent domain. NTMWD reserved \$3,924,000.00 toward this reimbursement if needed, although RCEC required no upfront funding.
- NTMWD reserved an additional \$1,305,000.00 in a separate agreement to reimburse RCEC for its costs to design the high voltage portions of the electric substations at the BDL dam and Leonard WTP sites, including the HSPS. RCEC requested no upfront funding for this project as well.
- RCEC obtained the CCN for both projects, and they have completed construction of the transmission lines and high voltage interconnect switching stations.
- RCEC also has completed construction of their portions of the two electric substations that were eligible for cost recovery from TCOS.

#### TERMINATION AGREEMENT

- The PUC has approved RCEC's request for cost recovery from TCOS, so NTMWD has no further obligation to RCEC for this work. Both RCEC and NTMWD wish to terminate these agreements.
- This document finalizes NTMWD's commitment and acknowledges that RCEC's costs were recoverable through TCOS.
- The Termination Agreement was reviewed by Lloyd, Gosselink, Rochelle and Townsend, P.C., and a copy is attached to this Administrative Memorandum.

#### **TERMINATION AGREEMENT**

#### (RELATED TO CONSTRUCTION OF ELECTRIC UTILITY FACILITIES TO SERVE THE NTMWD LOWER BOIS D'ARC LAKE WATER TREATMENT AND WATER PUMPING FACILITIES)

THIS TERMINATION AGREEMENT ("Termination Agreement") is entered into as of the last date of signature below (the "Effective Date"), by and between the North Texas Municipal Water District ("NTMWD") and Rayburn Country Electric Cooperative, Inc. ("Rayburn"). Rayburn and NTMWD are collectively referred to as the "Parties" and each individually as a "Party". Capitalized terms used but not defined in this Agreement shall have the meanings given to them in the Project Agreements.

#### RECITALS

WHEREAS, the Parties previously entered into that certain Agreement for Pre-Construction Work Associated with One Transmission Line dated August 24, 2016, and that certain Agreement for Reimbursement of Costs for Two Transmission Lines and Portions for Two Substations dated January 25, 2019 (collectively, the "Project Agreements"); and

WHEREAS, the Project Agreements obligated Rayburn to construct electric utility facilities to serve the NTMWD Bois d'Arc Lake water treatment and water pumping facilities located in Fannin County, Texas, as more particularly described in said Project Agreements (the "Work"); and

WHEREAS, the Work is complete and the Public Utility Commision of Texas ("PUCT"), by its Order, dated October 6, 2022, approved Rayburn's Application for Transmission Cost of Service ("TCOS") recovery, which included all costs incurred by Rayburn for the Work, in PUCT Docket No. 52353; and

WHEREAS, Rayburn desires to release NTMWD from its obligation under the Project Agreements to reimbure Rayburn for any costs of Work not recoverable as TCOS; and

WHEREAS, the Parties desire to terminate the Project Agreements on the terms set forth herein.

#### AGREEMENT

NOW THEREFORE, in consideration of the mutual covenants, agreements and obligations of the Parties herein set forth, the Parties agree as follows:

- 1. The Project Agreements are hereby terminated as of the Effective Date, defined hereinabove, on the basis that the Work contemplated thereunder is complete and the costs incurred by Rayburn for Work were recovered under TCOS, SAVE AND EXCEPT that NTMWD shall release and hold Rayburn harmless from any and all claims and liability related to liens filed by contractors, entities or other persons as a result of the Work; and
- 2. As a result of this termination, each Party, on behalf of itself and its respective present and former subsidiaries, affiliates, officers, directors, members, successors, and assigns (collectively, "Releasors") hereby releases, waives, and forever discharges the other Party and its respective present and former, direct and indirect, affiliates, employees, officers, directors, members, agents, representatives, permitted

successors, and permitted assigns (collectively, "Releasees") of and from any and all actions, causes of action, suits, losses, liabilities, rights, debts, obligations, costs, expenses, liens, bonds, covenants, promises, damages, judgments, claims, and demands, of every kind and nature whatsoever, whether now known or unknown, foreseen or unforeseen, matured or unmatured, suspected or unsuspected, in law or equity (collectively, "Claims"), which any of such Releasers ever had, now have, or hereafter shall or may have against any of such Releases for, upon, or by reason of any matter or cause from the beginning of time through the date of this Termination Agreement arising out of or relating to the Project Agreements, except for any Claims relating to rights and obligations preserved by, created by, or otherwise arising out of this Termination Agreement.

**No Representations**. Rayburn, its agents and employees have made no representations, promises, or made any inducements, written and verbal, which are not contained herein. The Parties are not bound by or liable for any statement, representation, promise, inducement, understanding, or undertaking of any kind or nature (whether written or oral) with regard to the subject matter hereof not set forth or provided for herein. Each Party agrees that it is not relying on any statement not herein contained.

**Texas Law**. This Agreement shall be governed and construed in accordance with the laws of the State of Texas excluding any conflict of law or other provision referencing the laws of another jurisdiction.

**Recitals**. The recitals at the beginning of this Agreement are incorporated into this Agreement for all purposes.

**Further Assurances**. Each Party agrees to execute and deliver any such instruments and to perform any such acts as may be necessary or reasonably requested by any other Party in order to give full effect to the terms of this Agreement.

**No Third-Party Beneficiaries**. Nothing in this Agreement is intended to confer any right, remedy, or claim under or by reason of this Agreement to any party other than NTMWD and Rayburn.

**Authorization.** Each person signing this Agreement as a party or on behalf of a party represents that he or she is duly authorized to sign this Agreement on such party's behalf, and is executing this Agreement voluntarily, knowingly, and without any duress or coercion.

**Counterparts**. This Agreement may be executed in multiple counterparts, each of which shall be deemed an original and all of which taken together shall be but a single instrument.

#### BACKGROUND

The significant collection of sediment occurring in the lake bottom depression around the raw water pump intake structure results in source water quality that is challenging to treat under many conditions. To access higher quality water, dredging of the Bonham WTP intake structure is required.

Due to the specialty nature of dredging operations, in May 2022 the Board of Directors approved Consent Agenda Item No. 22-05-06 authorizing the use of Competitive Sealed Proposal procurement approach for this project.

PROJECT PURPOSE

- Provide access to generally lower-turbidity water at the water treatment plant intake
- Improving raw water quality to make the treatment process more efficient and reliable

#### PROJECT COMPONENTS

- Dredge approximately 4,100 cubic yards of material (estimate, based on design phase survey) from the intake channel and at the raw water pump station intake
- Dredge collected material from inside the intake structure
- Sediment sampling
- Develop the temporary decant site to accept dredgate
- Install temporary piping to move dredgate to the decant site, and to return water from decant site to Lake Bonham
- Install new marker buoys around the intake structure to encourage a safe boating buffer

#### BEST VALUE PROPOSAL

NTMWD utilized a Competitive Sealed Proposal selection approach per Section 2269 Contracting and Delivery Procedures for Construction Projects of the Texas Administrative Code. This method involves the evaluation and scoring of proposals according to certain key project approach criteria, including price, experience with similar work and conditions, planned approach for this project, and key personnel. Proposals were received from two contractors on Tuesday, October 11, 2022.

Dredge America, Inc. achieved the best overall evaluated score, including the lowest price of \$999,975, and is recommended as providing the best value proposal to the District.





- A City of Parker 12-inch waterline (WL) was not in the location indicated by as-built plans provided by the City, and was found to be in direct conflict with the relocations at 3 locations along the 84-inch pipeline.
- The contractor completed the 42-inch waterline relocation and tie-in during spring 2022, but was delayed in relocation of the 84-inch line until the conflicts could be resolved. The delays resulted pushed the work time beyond the available shutdown window, which is driven by critical system demands. Garney was asked to demobilize until the Fall 2022 shutdown season, which started October 31st.

#### BACKGROUND

#### PROJECT PURPOSE

- Provide a tower at the Forney-to-Terrell Pump Station Site to boost signal strength between the South System and Wylie.
- Primary and current communication with remote sites in the South Transmission System is via radio repeating through the Wetlands Conveyance Pump Station to Wylie. Radio communication has degraded over time due to increased volume of data transmitted through the network and area development, which impacts signal paths.
- The Engineer's estimated opinion of probable construction cost (OPCC) is \$2,000,000.
- This project was originally advanced and authorized as the Hailey Pump Station, Ground Storage Tank Rehabilitation and Site Improvements and Forney-to-Terrell Communications Tower. When bids for this project came in at twice the Engineer's OPCC the scope items related to the Hailey Pump Station site were re-evaluated for timing of the most critical needs.
- It was determined that while the Forney-to-Terrell Pump Station Communications Tower remains a priority, the Hailey Pump Station site tasks can be delayed in an attempt to align with a more- advantageous bidding environment.
- In restructuring the scope of this project, it is also recommended that the project name be changed to Forney-to-Terrell Pump Station Communications Tower to reflect the reduction in scope.

#### RECEIPT AND EVALUATION OF BID

Only one bid was received in this second round of bidding as opposed to three bidders in the initial bid effort. It is likely that the removal of civil and structural scope items impacted the interest of at least two of the original bidding general contractors. Despite the reduced pool of bidders the price for the communications tower was 26% higher than OPCC, which is an improvement over the original scope of the project that was 100% higher than the OPCC. The communications tower and related radio equipment integration are specialized construction that have a very limited pool of competent and available contractors, which contributes to higher base costs than more general construction work.

The project remains a critical need for reliability of the transmission system and the bidder and subcontractors are experienced and knowledgeable for this scope of work.



- Increase conveyance capacity to meet the immediate and projected 2040 projected flow conditions due to population growth in the cities of Forney, Heath, and Rockwall as recommended by the Buffalo Creek Interceptor System, Forney Interceptor System, Lower East Fork Interceptor System, and Mustang Creek Interceptor System Capacity Assessment by Burgess and Niple in 2017.





#### TABULATION OF BIDS AND AWARD OF CONTRACT AND INSPECTION SERVICES AGREEMENT

#### ACTION (What)

Award a construction contract and inspection services agreement for the 121 Regional Disposal Facility (121 RDF) Sectors 6B and 6C Mass Excavation project.

#### PURPOSE (Why)

This project excavates Sectors 6B and 6C for future development of the landfill liner and leachate collection system to continue to serve the Solid Waste member cities through the 121 Regional Disposal Facility.

#### RECOMMENDATION

The Executive Director, NTMWD staff and Biggs and Mathews Environmental, recommend the Board of Directors authorize the award of a contract as follows:

#### BACKGROUND

#### PROJECT PURPOSE

- Excavation of Sectors 6B and 6C of the 121 Regional Disposal Facility.
- NTMWD generally excavates Austin Chalk material for the next cell to be constructed.
- Cell progression is from east to west and due to increasing depth as excavation activities approach the western end of the landfill the excavation quantity is greater than in-house capability.
- A third-party contractor will ensure excavation grades are met when cell construction must begin.
- This project will ensure sufficient airspace is available to support landfill operations.

#### PROJECT COMPONENTS

- Approximately 600,000 cubic yards (CY) of Austin Chalk excavation
- Approximately 10,000 cubic yards of clay soil stockpiling
- Approximately 6,000 linear feet of silt fence
- Construction of 121 RDF Austin Chalk stockpile

#### LOWEST RESPONSIBLE BIDDER HISTORY

CST Sitework, LLC (CST) was the lowest bidder. CST did not attend the pre-bid meeting. Biggs & Mathews Environmental (BME) and NTMWD staff contacted CST to confirm it understood the scope of the project. CST stated it was unaware of the extent of excavation in the Austin Chalk rock layer and requested withdrawal of its bid. On Monday October 24, 2022, NTMWD staff received a formal request from CST Sitework, LLC to withdraw its bid.

Rigid Constructors, LLC (Rigid) submitted the lowest responsible bid. Rigid attended the pre-bid meeting, visited the construction site and confirmed to BME and NTMWD staff it understands the full scope of work including the extent of Austin Chalk excavation.

Rigid has completed the following list of similar projects:

- Maxter Distribution Facility Mass Grading Phase I, Houston TX, 850,000 CY of Excavation
- Vermilion Regional Detention, Lafayette Parish LA, 6,200,000 CY of Excavation
- Comite River Diversion Segment 2A, Baton Rouge LA, 1,400,000 CY of Excavation
- Calcasieu River CDF-D, Westlake LA, 3,200,000 CY of Excavation

Based on their standing as lowest responsible bidder, the information provided, reports by the supplied references, and history of successful project completion, the NTMWD staff and Biggs and Mathews Environmental recommend award of the contract to Rigid Constructors, LLC.


#### INSPECTION SERVICES AGREEMENT

#### INSPECTION SERVICES FEE

- NTMWD normally provides inspection services for the NTMWD projects. However, due to current project workload, the NTMWD staff recommends that Biggs and Mathews Environmental (BME) be retained to provide full-time inspection services. BME is currently the engineer of record for the 121 Regional Disposal Facility.
- BME has proposed to provide:
  - Eight days per month to observe project activities at the site and time for project management (1,040 hours at a rate of approximately \$126.54 per hour, resulting in the amount of \$131,600.00)
  - Collect aerial drone topography data no less than once per month for quantity verification (20 total at a rate of \$2,200.00 per flight, resulting in the amount of \$44,000.00)
  - Four gridded ground surveys to verify that the contractor has excavated to design grades (4 at a rate of \$2,100 per survey, resulting in the amount of \$8,400)
  - NTMWD staff will oversee the actions of the contracted personnel
- NTMWD staff has reviewed the hourly rate and maximum hour projection proposed by BME and recommends them as representative of the anticipated effort.

#### FUNDING

FUND(S): Funding in the amount of \$2,947,352 to Rigid Constructors, LLC and \$184,000 to Biggs and Mathews Environmental is to be made available utilizing the Regional Solid Waste System 2022 Construction Fund.
